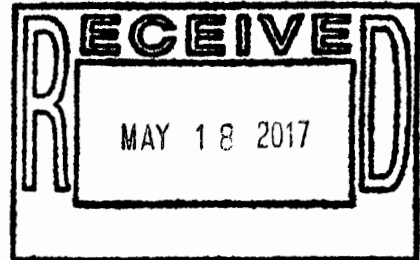

Dear Ms. Barkman:

I am one of the attorneys who represent Marion A. Hecht, as Receiver for Joseph Forte L.P. in the above-captioned matters. It has come to our attention that the mailings to Joseph Forte in these matters have been returned as undeliverable. For example, on April 25, 2017, the docket in the *SEC* matter reflects that a recent order mailed to Mr. Forte was returned as "Not Deliverable as Addressed, Unable to Forward."

The address listed on both the *SEC* and *CFTC* dockets for Joseph Forte is 225 Fawnhill Road, Broomall, PA 19008. However, on November 25, 2009, Mr. Forte was sentenced to 180 months (15 years) imprisonment, which he is currently serving. *See USA v. Forte*, 2:09-cr-00304-JD-1 (Dkt. No. 35). Mr. Forte is currently incarcerated at FCI Fairton in Fairton, New Jersey. *See* Federal Bureau of Prisons Inmate Locator (bop.gov/inmateloc), enclosed herewith.


